### Identify your competences

Do you have experience of or an interest in work in the forestry industry, and wish to know how you can use your experience for a career in Sweden?

By carrying out a self-assessment, you get an idea of what is required for your specific profession.

You do the self-assessment by completing a form associated with a career on the Swedish labour market Your responses are intended to be used as a support, and you can use the self-assessment questionnaire in dialogue with an employment officer. The responses can make it easier for the Swedish Public Employment Service to make the right choice among their various methods of helping you. It may be that you need support for how to be able to use your competences in Sweden, to acquire information about how to continue, to supplement your education, gain work experience or acquire validation.

The questions in the self- assessment are based on those requirements that exist for various careers in Sweden. Responses are based on your knowledge and experience in that occupation.

All of your knowledge and experience is taken into account. It is you who assess your own skills and competences.

What is regarded as a qualification in this questionnaire is

- Experience of forestry in some form
- Professional experience as a driver of heavy machinery, for example an excavator
- An interest in working in the forest

#### 1: No experience

You may have theoretical knowledge but no practical experience

#### 2: Limited experience

You had opportunities to do this type of work while in training.

#### 3: Good experience

• You have references and a work certificate applying to work in the industry for a year

#### 4: Considerable experience

 You have practical experience over several years and can relatively quickly begin to work independently

#### 5: Very considerable experience

- You should be able to be tested at a workplace directly as a supervisor, manager or expert
- You have experience in organising and developing the business, and experience of administration and management
- You have experience in communicating how work in the sector should be carried out and can involve and motivate your co-workers
- You have experience in organising resources for various projects/groups/areas of activity/co-workers

Use the free text fields, at the bottom of the questionnaire, if you want to develop your experiences further. Maybe you have experiences within the industry, but that questions about these are lacking in the self-assessment questionnaire.
