Identify Your Skills

Do you have specialized professional experience? Would you like to know how you can use that experience in Sweden?

By carrying out a self-assessment, you can get an idea of the skills that are required in your line of work.

To carry out this self-assessment, you simply complete a survey of questions related to a specific profession in the Swedish labour market. Your responses to this questionnaire are intended to be used as a helpful tool in finding the job that is right for you. You can use the self-assessment questionnaire in dialogue with an employment officer. Your responses will help both you and Arbetsförmedlingen (the Swedish Public Employment Service) to make well-informed decisions about how they can best be of assistance. Perhaps you need some help in determining how to apply your skill set here in Sweden, or require information and advice about what the next step in your career path ought to be: Should you complete your education, gain work experience, or acquire a professional certification?

The questions in the self- assessment are based on the requirements imposed by Swedish law to practice a given profession. You should base your responses solely upon your own knowledge and experience within that profession.

All of your knowledge and experience is taken into account. It's up to you to assess your own skills.

This self-assessment survey concerns the qualifications required to work in the wood industry.

Please assess your experience and skills using the rating system below. This will allow the Swedish Public Employment Agency to give you the best possible guidance and support.

Use the following scale as a basis for identifying and assessing your skills

1: No experience

You may have theoretical knowledge, but lack any practical experience

2: Limited experience

You gained limited practical experience while undergoing your training

• You have references and a work certificate attesting that you have worked in the industry for less than a year.

4: Ample experience

 You have several years of practical experience, and would be able to start working unsupervised almost immediately

5: Very considerable experience

- Your professional experience is such that you could immediately assume the position of a supervisor, manager or expert
- You have experience in organising and developing a business, as well as administrative and managerial skills
- You have experience in communicating how work in your industry should be carried out, and can involve and motivate your colleagues.
- You have experience in organising resources for various projects/groups/activities/colleagues

You may use the free text fields at the bottom of the questionnaire to further describe your professional experience. Perhaps you have industry experience, but the questions provided in the self-assessment do not touch upon your specific skills.
